- 27** Any person resident in the state of Tasmania and handling an exhibit in any TCA Inc. exhibition must be a financial member of the TCA Inc.
- 64C** A dog may be disqualified from exhibition if found to have had a substance, preparation, powder or fluid applied to and remaining on the dog during exhibition to such an extent as to deceive or to be likely to deceive a judge.

Ulverstone Kennel Club has advised that Mr W Stevenson (NSW) will be replacing Mr S Rose (NSW) at their shows that are scheduled for 05 and 06 February 2011. The club also advises that there will be one catalogue and one set of numbers for the 3 fixtures and that the cost of the catalogue is \$6.00 and not \$4.00 each for the 3 shows.

# TASMANIAN CANINE ASSOCIATION INCORPORATED

## RULES FOR THE ELECTION OF COUNCILLORS

1. Those members eligible to vote at an election for councillors shall have been a financial member of the Tasmanian Canine Association Inc. for a period of not less than three (3) months of the financial year preceeding that in which the election is to be held i.e. have paid membership not later than 30 September in each year, and is a current financial member as at 31st December 2010.
2. A member under the age of eighteen (18) years is **not** eligible to vote at an election for councillors.
3. Only those members resident in the state of Tasmania shall be eligible to vote at an election for councillors.
4. **An eligible financial member of the TCA Inc. may cast a vote for up to but not more than four candidates. The four candidates who receive the highest number of votes shall be elected to the vacant positions for a three year term February 2011 to February 2014. The candidate who receives the fifth highest number of votes shall be elected to the vacant position for a two year term February 2011 - February 2013. In the event of a tied vote for the last position, the names of those candidates who received the identical number of votes in the tie shall be subject to a simple draw, and the winner of the draw shall be duly declared elected as a Councillor.**
5. A ballot paper shall be sent to eligible members and shall be completed and in the hands of the Returning Officer, not later than **4 pm FRIDAY 31 DECEMBER 2010** at the address thereon. Any ballot papers received by the Returning Officer, subsequent to that date and time, shall be retained unopened by the Returning Officer.
6. A ballot paper received from a member, whose status of membership does not comply with (1) above, shall be retained unopened by the Returning Officer.

Being actively involved across disciplines and having sound business skills, I feel I could continue to contribute toward progressing all canine activities and the continual development of the TCA.

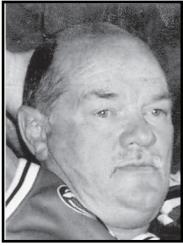

# **CODE OF ETHICS OF RESPONSIBLE DOG OWNERSHIP INCLUDING KEEPING, WELFARE BREEDING, SELLING AND DISPOSING OF DOGS BY MEMBERS OF THE TASMANIAN CANINE ASSOCIATION INC.**

## **SECTION 1 – COMPLIANCE WITH CODE OF ETHICS**

Each member, upon signing an application for membership or renewal of membership of the T.C.A. Inc, and being duly elected to general membership of the TCA Inc, shall, in addition to agreeing to be bound by the Constitution, Rules and Regulations of the TCA Inc, be also bound by the TCA Inc's Code of Ethics relating to responsible dog ownership, including the keeping, welfare, breeding, selling and disposing of dogs by members to the effect of the terms and conditions set out under Section 2 hereof.

## **SECTION 2 – CODE OF ETHICS AND UNDERTAKING**

In consideration of the Tasmanian Canine Association Inc electing me to its general membership and approval of that renewal from time to time, I pledge to the Tasmanian Canine Association Inc that: -

1. I shall ensure that at all times all dogs under my control are properly housed, fed, watered, exercised and receive proper Veterinary attention, if and when required.
2. I shall not allow any dogs under my care to roam at large and when away from home ensure that they are kept fully leashed, or under effective control, at all times. All dogs must be able to stand up to full height and be able to turn around with ease in any crate in which it is confined.
3. I shall breed only for the purpose of improving the **quality and/or working ability of the breed in line with the breed standard** and not for the pet market or any other commercial purpose.
4. **I shall not breed from any bitch kept by me causing it to whelp before it is 12 months of age and I shall not breed any bitch kept by me causing it to whelp more than twice in any 18 month period. I will not breed any bitch kept by me causing it to whelp more than 6 times without prior written approval from the TCA Inc Council.**
5. I shall not permit any of my pure bred dogs to be mated to a dog of a different breed, to a cross-bred dog, or to an unregistered dog of the same breed.
6. I shall not sell or otherwise transfer from my care any puppy under 8 weeks of age, **within Australia and 11 weeks of age overseas, the pup must have had its initial vaccination for distemper and parvo-virus.**
7. I shall ensure that all persons acquiring dogs from me clearly understand their responsibility for the care and welfare of the animal, that they have the time and facilities (i.e. adequate fences, sufficient room and proper shelter etc) to perform their obligations.
8. I shall provide to all purchasers of dogs sold or placed by me, written details of all dietary and immunisation requirements and/or an appropriate publication relating to such requirements and responsible dog ownership.
9. I shall not sell any dog to commercial dog wholesalers, retail pet dealers, or directly or indirectly allow a dog to be given as a prize or donation in a contest of any kind.
10. I shall not knowingly misrepresent the characteristics of the breed, nor falsely advertise, or mislead any person regarding the performance of any dog.
11. I shall ensure when selling or transferring a dog to another person that documents as required by TCA Inc Regulation 58, will be provided to the purchaser or transferee.
12. I undertake not to advertise puppies for sale as TCA Inc registered until the application for registration has been lodged with the TCA Inc Office.

## SHOW AND TRIAL REGULATIONS

All exhibitions conducted by the Tasmanian Canine Association Inc. and its affiliates are conducted under the rules and regulations of the Association, a copy of which may be inspected at the office of the secretary of the exhibition on the day of such exhibition.

The following rules/regulations apply to all exhibitions:

### **Financial Members:**

A person 18 years of age and over and who is a resident of Tasmania may not exhibit, handle, officiate in the judging ring or register an animal unless he/she is a current financial member of the TCA Inc. A person seven years and under the age of eighteen years who handles a dog in the judging ring is required to be a junior member of the TCA Inc. or a member of an affiliated club. At least one parent or guardian is required to be a financial member of the TCA Inc.

All dogs shall be entered for exhibition on the official cheque-book entry form and must have all details required for publication legibly completed thereon and in ink.

Entry fees must accompany the entry form and should be paid by cheque or money order (refer Australia Post regulation).

**A stamped, self-addressed envelope must be included for the return of number discs for championship shows, obedience and retrieving trials.**

### **Substitute Judges:**

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable - refer TCA Inc Regulation 227.

It is the exhibitor's responsibility to have his/her exhibit/s available for judging in all classes or events for which it is correctly entered and for the classes for which it subsequently becomes eligible - TCA Inc Regulation 33.

## TASMANIAN CONTEST OF CHAMPIONS REGULATIONS

1. This competition is organised by the Combined Breeds Dog Club of Tasmania Inc.
2. Any dog/bitch must have attained the title of Australian Champion by 31 December each year that is confirmed by the TCA Inc office prior to 15 January in the following year.
3. Each year the number of judges to be appointed shall be determined by the committee of the Combined Breeds Dog Club of Tasmania Inc.
4. The judges will be selected by the committee of the Combined Breeds Dog Club of Tasmania Inc and will be utilised the next day to officiate at an All Breeds Championship Show. The winner of the Contest of Champions will be excluded from exhibiting at this fixture.
5. For dogs/bitches to compete at the Contest of Champions all qualifying points must be obtained at Tasmanian shows.
6. Dogs/bitches must gain their wins in Tasmania but do not have to be owned outright by a resident of Tasmania. Dogs/bitches, at the time of qualifying, wholly owned by a person/s not resident in Tasmania are ineligible.
7. There will be 32 invitations issued to the top qualifying dogs on the following basis:
  - The top 4 dogs/bitches in each Group will be invited to compete.
  - The other 4 invitations will be determined by a wild card draw.
 Scoring for these positions will be as follows:  
 Best in Group – 5 points and for every multiple of 25 exhibits over 50 another point is allocated.  
 Runner Up Best in Group – half the number of points allocated to the Best in Group.
  - If any dog/bitch invited cancels, withdraws or does not accept the invitation an invitation will be issued to the next highest scoring exhibit.
8. Invitations will be forwarded to exhibitors as soon as possible but no later than 15 January in each year.
9. Judging will be by means of a knock out competition, 16 heats with the winner of each heat going through to the next round until 2 only remain. There will be one final winner. The order of judging will be determined by a public draw at the event prior to the commencement of judging.
10. The TCA Inc Council will appoint an independent adjudicator for the event.
11. In the event of any contingency arising which is not covered by these Regulations the club's committee, in conjunction with the TCA Inc appointed adjudicator, has the power to make such rulings as they determine are in the best interests of the club and the continuing prestige of the event.
